

The final examination of the institute shall be conducted under Common Examination System of the respective university as well as in accordance with the norms as prescribed by the Council from time to time. The teaching /core faculty should be appointed as per RCI norms before the commencement of the programme. A list of core faculty / guest faculty appointed along with their appointment order, rehabilitation qualification, experience, RCI registration number, etc. may be furnished for perusal to the Council.
